2. Eligible Bidders may obtain further information and inspect the bidding documents at the Madhav Narayan Municipality, Office of the Municipal Executive, Madhopur, Rautahat, Province No. 2.
3. A complete set of bidding documents may be purchased on or before **Feb 14, 2021** from above office by eligible bidders on the submission of a written application along with the copy of company/firm registration certificate, tax clearance of 2076/077, authorization letter and upon payment of a non-refundable fee as mentioned above or should deposit the cost of bidding document in **Siddhartha Bank, Madhopur, Rautahat, Branch, Dharauti account no. 00215381280** on behalf of this office and submit their bids electronically by downloading the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document in the Project's account as specified above.
4. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:- NRs. 28,80,00,000.00
Minimum Work experience of similar size and nature: - NRs. 15,36,00,000.00
Bids must be submitted to *Madhav Narayan Municipality, Office of the Municipal Executive, Madhopur, Rautahat, Province No. 2* on or before **12:00 hours on Feb 15th, 2021**. Documents received after this deadline shall not be accepted. Bids received by the above mentioned deadline shall be opened in the presence of Bidders' representatives who choose to attend at the address above **at 14:00 hours on Feb 15th, 2021**.
5. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting as mention above, which shall be **valid for minimum 30 days** beyond the bid validity period [*i.e. June 15th, 2021*].
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Noncompliance with this instruction shall result in disqualification.
8. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
