1. The *Madhav Narayan Municipality, Office of the Municipal Executive, Madhopur, Rautahat, Province No. 2* invites sealed bids from eligible bidders for the procurement of following under *National Competitive Bidding (NCB) procedures*.

2. Eligible Bidders may obtain further information and inspect the bidding documents at the Madhav Narayan Municipality, Office of the Municipal Executive, Madhopur, Rautahat, Province No. 2.
3. A complete set of bidding documents (Hard Copy) in English may be purchased on or before **Feb 27, 2020** from above office by eligible bidders on the submission of a written application along with the copy of company/firm registration certificate, tax clearance of 2075/076, authorization letter and upon payment of a non-refundable fee as mentioned above or should deposit the cost of bidding document in **Siddhartha Bank, Madhopur, Rautahat, Branch, Dharauti account no. 00215381280** on behalf of this office.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's account as specified above.

4. Only eligible bidders with the following key qualifications should participate in this bidding:  
**Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: For contract 1- NRs. 7,80,00,000.00 and for contract 2- NRs. 8,52,50,000.00**  
**Minimum Work experience of similar size and nature: For contract 1- NRs. 4,16,00,000.00 and for contract 2- NRs. 5,45,52,000.00**
5. Bids must be submitted to *Madhav Narayan Municipality, Office of the Municipal Executive, Madhopur, Rautahat, Province No. 2* on or before **12:00 hours on Feb 28th, 2020**. Documents received after this deadline shall not be accepted. Bids received by the above mentioned deadline shall be opened in the presence of Bidders' representatives who choose to attend at the address above **at 17:00 hours on Feb 28th, 2020**.
6. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting as mention above, which shall be **valid for minimum 30 days** beyond the bid validity period **[i.e. June 28th, 2019]**.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Noncompliance with this instruction shall result in disqualification.
9. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
